Scott County Public Schools is seeking bids for a contractor to install new hardwood gym flooring for Nickelsville Elementary School (11415 Nickelsville Hwy PO Box 136 Nickelsville, VA 24271). The School Maintenance Department will remove the existing hardwood floor and have the existing subfloor ready for the installation of the new hardwood gym flooring. Scott County Schools request for the contractor to install the new hardwood flooring, install volleyball standards, paint all new lines for volleyball and basketball including a high school 3-point line for a 90' x 50' basketball court, finish coat/seal the gym floor, and coordinate moving the bleachers as needed to install and finish the new flooring. A drawing with dimensions and line markings will be available at the pre-bid, and available from the School Maintenance Department at 298 Jennings Street, Weber City, Virginia 24290 and office phone (276) 386-6561. The hours of installation shall be coordinated with the School Principal and/or the Maintenance Department if school is in session. A contingency fund of 20% is requested to be included in the total bid.

Due to insurance coverage of only the damaged portion of the floor and school funding, Scott County Schools request 2 separate bids.

- 1) Bid to replace 3,626 square feet (+/- 2%) of the damaged floor, which will include a 74' wide x 49' long section of the gym. (Wall to wall and end of court to 2' past half court)
- 2) Bid to replace the complete gym floor totaling 6,956 square feet (+/- 2%) 74' wide x 94' long.

Please include a 20% contingency fund in each of the requested bids

The contractor completing the installation shall be responsible for all structural requirements required to meet all building codes. The installing contractor/sub-contractor shall be responsible for contacting the local building code official for any and all inspections required.

Sealed bids will be received until 2:00 p.m., April 12, 2018, at the Scott County School Board Office, 340 East Jackson Street, Gate City, Virginia 24251, at which time they will be publicly opened and read. Sealed Bids shall be marked as "sealed bids for Nickelsville Elementary Gym Floor". Proposals should include all services as requested in the RFP.
