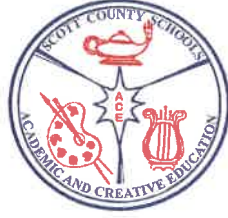

### Scott County Public School District Request for Proposal-Physical Therapy Services

Scott County Public Schools' Central Office is issuing a request for sealed bids for physical therapy services from responsible vendors. Proposals need to address the following specifications:

Sealed Bids are due by 1:00 p.m. on Friday, October 5, 2018. All bids may be submitted to the Scott County School Board's Central Office, 340 E. Jackson Street, Gate City, VA 24251 or may be mailed to the Gate City address marked: **Scott County School Board: Physical Therapy Services. Attention: Brenda Robinette.** Bids will be opened and reviewed on October 5, 2018 at 1:00 p.m. and the award will be granted and new services will be expected to begin on Wednesday, October 10, 2018. Scott County Schools has the right to reject any and all proposals. Any bid not addressing the services Scott County determines necessary to the development of the Scott County School System student such as furnishing personnel, labor, and consultation when needed and other services; and providing sufficient and adequate physical therapy services to students of the Scott County School System will not be considered.

Scott County School System will determine the award based but not limited to the following:

- a. The vendor will provide physical therapy evaluations, treatments and assessments by licensed staff that is appropriate to the student in a school setting.
- b. The vendor will develop a treatment plan and/or manage programs for referred students as stated in state guidelines.
- c. Maintain communication between school personnel and other appropriate treatment staff.
- d. Monitor student progress and report those findings to appropriate personnel.

Scott County School System will begin said agreement October 10, 2018 with an option to renew for four (4) one year additional terms. This agreement shall be terminated within 30 days by either party if an agreement of services cannot be reached.

The vendor awarded the bid shall provide insurance for their personnel under this agreement with Scott County School System.

Payment terms will coincide with the Scott County School Board meeting dates.

During the performance of this contract, the vendor will not discriminate against any employee or applicant for employment because of race, religion, color, sex, national origin, age, disability, or other basis prohibited by state law.

During the performance of this contract, the vendor agrees to provide a drug-free workforce.

During the performance of this contract, the vendor agrees to follow the Code of Virginia on sex offender's entry onto school property and provide written statements on all work forces on school property.
